Special Education

When you import your “**Programs Services Extract**” from your **Special Education System** (ClearTrack or IEP Direct), check the boxes:

- Safety Net - ONLY for 504 plan students if 504 plan allows (**Must also have 0264 Program Record**)
- Type of Disability – **Used to place a student in a Subgroup for Accountability**
- 0220::Alt Assess – Student must be ungraded and must take the NYSAA exam according to their DOB
- 0264::Section 504 Plan - Regular Ed students with modification

Cafeteria System

When you import your “**Data Warehouse Extract (or Tool)**” from your **Cafeteria System** (MiChoice or Nutrikids, etc), check the boxes:

- 0198::Poverty – **Used to place a student in a Subgroup for Accountability**
- 5806::Reduced Lunch (should ALSO have Poverty)
- 5817::Free Lunch (should ALSO have Poverty)

Student Management System

When you import your “Program Services Extract” from your SMS (eSchoolPLUS, PowerSchool, schooltool), check the boxes: *(FYI – most do, but some districts do not use their SMS as the source for the categories below)*

- 8272::Homeless Youth
- 1232 SIFE
- 8300 Foster Care
- CTE/Tech Prep **(Starting in SY 2020, only used by LEAs offering NYSED-approved programs)**
- UPK **(Required for UPK students ONLY, not ‘other’ PreK students)**
- Higher Education
- 8312 Biliteracy
- ELL Eligibility – ***Used to place a student in a Subgroup for Accountability*** (All LEP students)
- 8271 CDOS Credential
- ELL Programs – If a student is LEP Eligible, they should also have a LEP Program (All LEP students)
- 0242::NYSESLAT (ONLY for 1st yr LEP students!)
(A NYSESLAT record is only needed for 3-8 grade students who are in their FIRST year of ESL Services and will not be taking the regular NYS ELA exam. It allows districts to use the NYSESLAT exam (in place of the regular NYS ELA exam) for calculations of Accountability Participation and Performance.)
- Summer School Participation
- Prekindergarten Programs (UPK or ‘other’ PreK) (ALL PreK students)
- 8282 Immigrant
- 8261::Single Parent/Pregnant **(Must also have a CTE program record & be at ‘concentrator’ level of intensity)**
- 8292 Parent Armed Forces

When you import your “Program Services Extract” from your SMS (eSchoolPLUS, PowerSchool, schooltool) **or RTI Edge** (ClearTrack)
