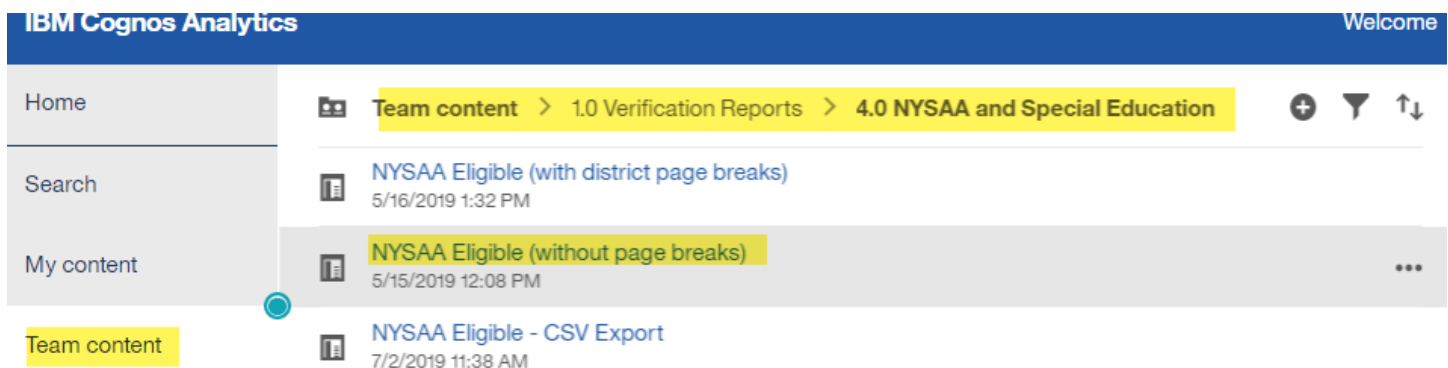

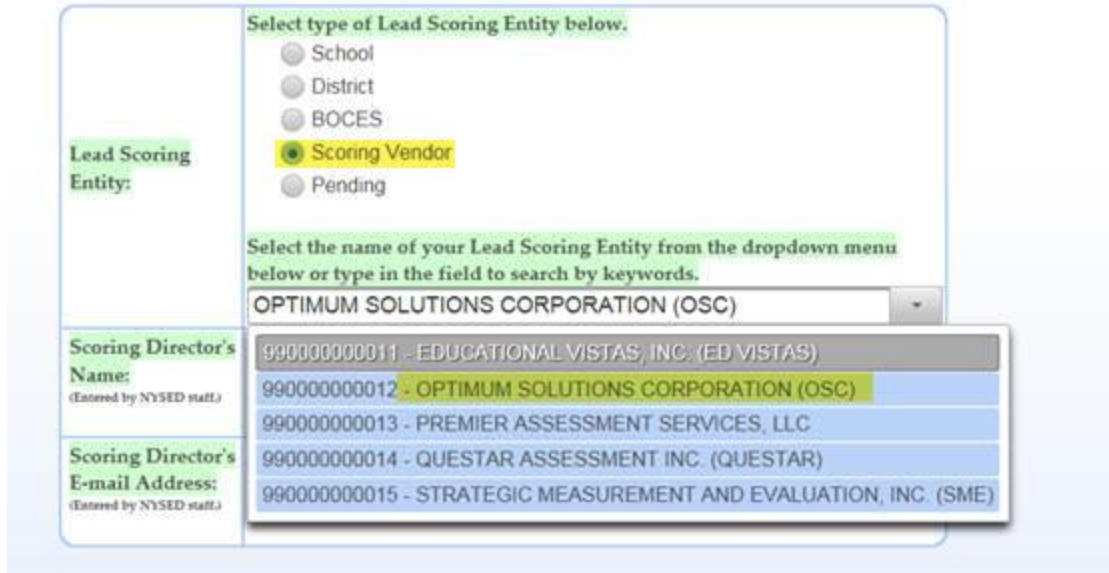
- d. See SIRS manual page 72 for age range chart. Secondary students (over grade 8) who will NOT be 18 in this school year are NOT on the report.

2. BEDS IMF and ePMF

- a. BEDS IMF is the entry of summary data for buildings and district. That entry is through the IRS Data Exchange application (IDEX) on the SED Business Application Portal. <https://portal.nysed.gov/abp> Data are Due **November 15**
- b. Beds day teacher assignment code entry is still being done as it was last year. Teachers log on to the TAA website, complete and submit their ePMF form. <https://eservices.nysed.gov/taa/> Teachers are to enter and submit by **December 20**
- c. Remember that Teachers new to your district must click on "Create Account"
- d. DDC's and principals should be able to download a spreadsheet of the teacher entered 2018-19 assignment codes.

3. Computer Based Testing (CBT)

- a. The ordering window is open for 3-8 ELA and math – paper and CBT. Due **December 6**
- b. Districts ordering CBT MUST specify a Lead Scoring Entity and if you are signed up for SCRIC Full Service Test Scoring, then you select
